~President's Message~

Colleagues,

It is my sincere hope that all of our members and their families who have been affected by the flooding in February are getting on with their lives as best as they are able. It was a long winter, and I am glad spring is finally here.

In February, several of your colleagues rallied and lobbied for your pensions and benefits. We made trips to Mountain Lakes and East Brunswick for meetings and to Mendham and Trenton to rally. We tried to convince the Senate and Assembly that the legislation they proposed would be damaging not only to education, but to your livelihood.

Although we managed to change some opinions in the Assembly, a majority of the legislation was passed - some of it with no amendments or arguments.

The legislation with the most immediate impact is the one which will require every one of our members to take a 1.5% salary cut, effective July 1, 2010, to "contribute" to health benefits. Although many of our members already contribute to their health care benefits, this deduction from your salary will be *on top* of that payment. The local newspaper insinuated that the PTEA was not cooperative when approached about ways to save the district money, so I find it interesting that this information was not in any newspaper article, nor did the BOE share it with the public, during the school budget presentations.

Colleagues, I want to let you know that despite what the press has reported about our profession, I feel there are few more noble endeavors than the journey to educate a child. Our members, from our Custodial/Maintenance employees to our Advanced Placement teachers, are professionals, who spend their days working to ensure that the children in this district are safe during the school day and that they leave us at the end of their school careers as productive, well-rounded individuals.

I thank you all for your dedication to your students.

~Legislative~

It's almost impossible to look at a NJ newspaper without seeing an article about Christie's attack on public education and its effects on taxpayers, teachers, students and the rest of the school community. Each district is coping in its own way with this drastic loss of funding. One lengthy bill, the Pension Bill, has been passed through all the branches of the state government. This bill has 16 provisions, most of which are directed at new employees. Current school employees will be affected by the requirement that we contribute 1.5% of our base salary toward our health benefits. Two other relevant bills are also being introduced. The first is the Voucher Bill (S1872) which would divert \$360 million in tax dollars to private and religious schools. The second bill would require New Jersey workers to live in New Jersey. As it now stands, this legislation would give current non-resident employees 30 months to move into NJ, and new hires would get four months to find a NJ home.

Please take seriously every request to contact your legislator to oppose these bills. It takes all of our combined voices to be heard in Trenton. Each one of us must communicate our views to our representatives to affect any change and to be part of the democratic process.
