Legislative – Dave Claeys (PTHS)

- 1. One of the key cases which is heading to the US Supreme Court this year is Friedrichs V. California. This case challenges the right for unions to take union fees from teachers automatically that are associated with the unions activities in negotiating contracts for all teachers in a district. In this case, 9 teachers in California that are part of a Christian Educators group, claim that it is a violation of their First Amendment rights to be forced to pay for the unions negotiations, even though they would benefit from the unions negotiated contract. If Friedrich's does win the case, it would deal a serious blow to unions and the power of unions as more individuals would potentially choose to opt out of dues, even though they too benefit from the negotiations.
- 2. Although PARCC results have been disseminated to school districts in the state. the state still has not released information that shows how many students chose to opt out of the testing. There is significant frustration among opponents of the PARCC standardized testing that 7 months after the test was administered, the state still hasn't released this data. There are also questions about how many students signed in for the tests but then completed it in too short a period of time to complete it seriously, in essence also opting out of the test. The state plans on releasing the formal opt out data in January, even though the scores for districts were released to the districts in November. There aren't any current plans for reporting the students who didn't actually take it even though they signed in on the day of the exam.

- 3. Massachusetts, which was the state that played a role in bringing about the idea of creating one standardized test for students in all states, and, was instrumental in the creation of the PARCC exam, has now joined the other states who have decided to walk away from PARCC. Originally, there were 24 states that signed up for PARCC. That is now down to 9 of the original 24 states, with New Jersey still one of the 9 remaining. This latest rejection of the test is a serious blow to the tests credibility.
- 4. New Jersey is toughening up its requirements for new teachers. The new standards include a full year of student teaching, going through a state evaluation system, being exposed to multiple types of classroom environment including at least one with students with disabilities, and, completion of a performance assessment.
- 5. A lawsuit, T.B., et al. V. NJ Department of Education, has been filed by several families against the NJ Department of Education. The suit claims that the NJ DOE issued new requirements for High School graduation. The new requirements do away with having to pass the HSPA and replaced it with successful passing of two of the PARCC exams. The suit contends that this is in direct violation of the NJ DOE's own regulations that require any changes to graduation requirements come through a process that allows for public comment.
- 6. Legislation has been introduced in the NJ Senate to place a constitutional amendment in the states constitution that would make it mandatory for the state to make its required pension contributions. The amendment would be put on the 2016 ballot for a public vote if it makes it through the senate.
