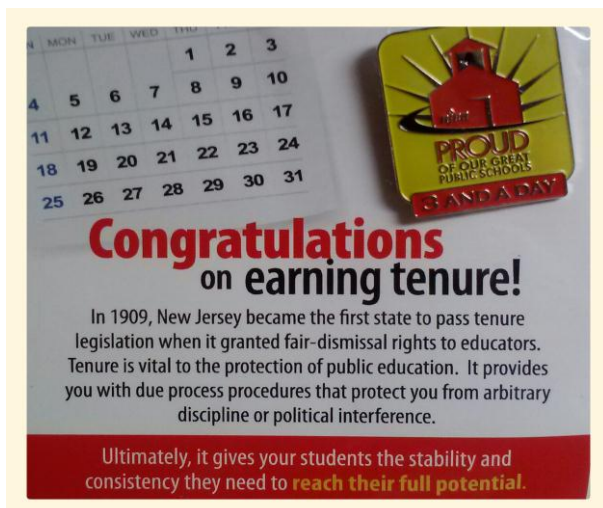

## Instruction/Professional Development Denise Donch (PV)

Members are reminded that all evaluations must be signed at the post conference even if the teacher plans on writing an objection to the evaluation (also known as "reflection piece") Teachers should sign the evaluation and include the following statement: A written objection will be forthcoming by \_\_\_\_\_ date (within 10 teaching days).

Teachers should send the final objection/reflection piece via email to the administrator so they have a record of sending it. They can follow up with a hard copy as well.

Lastly, teachers are encouraged to seek help from the SciP member of their building if they need help writing the objection/reflection piece. Teachers should be visiting the teachscape platform to assist in reviewing the domains for their write up. Here is the website: <http://login.teachscape.com> The username is your email address. Passwords will be the one you established when the account was activated. If you have misplaced your password, you can reset it by clicking the 'Forgot password' link on the login page and following the directions.
