### President's Message

It has been exhausting because we have faced many challenges.

It's been rewarding because we met those challenges head-on, and in many instances, we emerged stronger and more empowered than before.

The demands of the evaluation system to be implemented will be a challenge, next year, but thanks to our continued commitment to making sure we are educated about the legislation, we are better able to take control of our individual evaluations. I urge all members to continue to educate themselves on the legislation and on their rights in the process.

Because so much of the regulations are vague, NJEA has asked the Department of Education to delay the implementation of the system for another year, until the State can agree on the language of the exact implementation of some of the regulations. Stay tuned to the updates on NJEA.org, and to our website: pequannocktownshipea.org, to get current information over the summer.

Also, thanks to your continued efforts, the ESP bills NJEA presented to the Assembly have been passed with bi-partisan support, and are now awaiting the governor's signature. The passage of these bills will be a huge step toward protection for some of our most vulnerable members.

Through the work of our colleagues and our students and our community, we were able to restore one of the programs slated to be cut from the district. While we were unable to save the other program, we made a strong statement about the educational programs in the district. Our members stood up to make a statement about the many changes the administration has made in our district - and some of those changes were, if not reversed, at least revisited. We also made a strong statement about our commitment to be treated respectfully, as professionals.

We continue to face challenges for next year. We must be vigilant to protect our rights and the rights of our colleagues: to continue to advocate for each other. I know we are up to the challenge, as I have seen our strength.

Finally, I hope that some of you take advantage of NJEA's summer training events:

In July and August, NJEA will hold training for ScIPs, on SGOs and Common Core State Standards at the Trenton headquarters - many of us will be attending - let's carpool! ### Grievance

This year, numerous issues have been resolved at each building through our contractual grievance process. I would like to thank the AR's who are our front line of defense against contract and policy violations. They have been diligent in protecting your rights and working with the administration when necessary to insure that our negotiated contract is upheld. When necessary, we have filed grievance paperwork. As of now, the only outstanding grievance is the one filed in February of 2012 regarding members who were not granted a step on the new salary guide in accordance with our agreement with the BOE. We are awaiting an arbitration date, but hope to bring this issue to a resolution as we successfully negotiate a successor agreement. Stay tuned . . .
